

Terms and Conditions

DP World Ball Delivery Giveaway

Entry Details:

1. These are the terms and conditions of entry ("**Terms and Conditions**") for the DP World Ball Delivery Giveaway ("**Promotion**"). By participating in this Promotion, each entrant (including their parent and/or legal guardian as applicable) ("**Entrant**") accepts and agrees to be bound by these Terms and Conditions.
2. The promoter is the Fremantle Football Club Limited ABN (83 006 055 249) of 31 Veterans Parade, Cockburn Central WA 6164, ("**Promoter**").
3. Promotion commences at 9:00am on Tuesday 11 August 2026 and closes at 4:59pm on Wednesday 12 August 2026 ("**Promotional Period**"). All times indicated in these Terms and Conditions are in AWST.
4. There will be one (1) winner drawn ("**Winner**").
5. This is a game of chance via random electronic draw of all Entries ("**Draw**").
6. The Draw will take place as follows:
 - a. Time: 5:00pm
 - b. Date: Wednesday 12 August 2026
 - c. Location: 31 Veterans Parade Cockburn Central WA 6164
7. Entry is only open to individuals aged 12 years and older and who are residing in Western Australia. If the Entrant is under 18 years of age ("**Minor**"), a parent or guardian residing in Western Australia must enter the Promotion on behalf of the Minor and, if the Minor is the Winner, that parent or legal guardian must accompany the Minor for the duration of their participation in the Prize. Entrants (including parents and guardians) must not be:
 - a. directors, management, employees, officers and contractors of the Promoter and other agencies, firms or companies associated with this Promotion.
 - b. Immediate family members of directors, management, employees, officers and contractors of the Promoter. The Promoter reserves the right to verify the validity of Entries and Entrants (including but not limited to an Entrant's identity, age and place of residence). Incomplete or indecipherable Entries will be deemed invalid. The Promoter may, in its sole discretion, disqualify any Entry which in the opinion of the Promoter includes objectionable content, profanity, potentially insulting, inflammatory or defamatory statements, disqualify any entrant who tampers with the entry process, who submits an Entry that is not in accordance with these Terms and Conditions or who has, in the Promoter's opinion, engaged in conduct in entering the Promotion which is fraudulent, misleading, deceptive or generally damaging to the goodwill or reputation of the Promoter. This includes, but is not limited to, entrants using multiple email addresses to register multiple Entries. The Total Prize pool of this Promotion is valued at \$2,650 RRP (inc. GST).

The Winner/s will also be published in a pinned comment on the promotional post. By participating in this Promotion, the Entrant agrees for their name to be published in this manner if they are a Winner.
17. If the Prize is not claimed within 24 hours, the Promoter reserves the right to select a new Winner. The Promoter will conduct the unclaimed prize redraw on a date, time and place as determined by the Promoter and the Winner(s) of that redraw will be notified by direct message on social media.

Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter and any other parties associated with this Promotion (including its respective officers, employees and agents) is not responsible for and excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of or in relation to: (a) this Promotion; (b) any technical difficulties or equipment malfunction
